Public Hearing called to discuss proposed 2015 budget. 2015 proposed budget presented by Town Administrator Marsha Willhite with no town residents in attendance. Marty Campbell motioned to adjourn the Public Hearing at 7:25 p.m., seconded by Johnnie Lyons. Motion carried 5-0.

Mayor Brad Simon presided over the regular meeting of the Holly Board of Trustees on the above date at 7:26 pm. Roll was called. Trustee Frank Vazquez was absent. All present gave the Pledge of Allegiance.

Additions to Agenda. None.

Minutes, October 1, 2014 Regular and October 15, 2014 Special Board Meeting Minutes. Jerry Jones motioned to approve the minutes of the October 1, 2014 Regular Board Meeting and the October 15, 2014 Special Board Meeting. A second was received from Anthony Moldenhauer. Motion carried 5-0.

Approval of Current Bills. A motion was received from Trustee Larry Sitts, seconded by Trustee Jerry Jones to approved the current bills subject to review of the Finance Committee on November 12, 2014 at 8:30 a.m. Motion carried 5-0.

Public Appearances. Granada Police Chief David Dougherty was present to discuss operation costs of a police department. He also discussed the possibility of grant funding assistance.

Reports. Police Commissioner Report. Report available for board review. No discussion upon review.

Crew Report. Repaired and repainted walls at City Complex and replaced door. The repair recommendations resulting from the annual CIRSA inspection are being addressed at the Holly Gateway Park and Ball Park. Town shop, complex, theater, swimming pool and light plant passed inspection. Railroad Incidents for First Responders class was attended by Tysh, Aaron and Chris in Lamar. Dielectric testing performed on bucket trucks. Resident yard light repaired twice. First time bulb and eye were replaced. Second call to repair revealed the bulb had been shot with a bb gun. Lamar Light and Power installed transformer at south substation. Crew completed installation of fence around substation. Street lights repaired on Hwy 50, Main Street and other locations. All parks were winterized. Pothole repairs continue at 1st and Cheyenne, Barth St., North Main St. and Highland. Packer motor failed, repairing in house. Mercoid switch at south well was replaced. Chlorine ejector repaired at East well. Water leak at Hughes Court repaired. City of Lamar ran camera in sewer main at Big H Builders, Hazen's and McCracken's. Root ball was discovered at Big H Builders. Crew excavated root ball and re tapped sewer main. David and JW attended water class in Lamar on valves.
