

RESOLUTION 2011-1

A RESOLUTION SUPERSEDING 2007-9 BY THE BOARD OF TRUSTEES OF THE TOWN OF HOLLY ESTABLISHING RENTAL RATES FOR THE GRANT McCORMICK MEMORIAL BALL PARK RECREATIONAL VEHICLE (RV) SPACES, AND, TOWN OF HOLLY PARKS RESTROOM FACILITIES

WHEREAS, the Town owns property, specifically known as the Grant McCormick Memorial Ballpark, located at West Highway 50, which is primarily a municipal recreational area; and

WHEREAS, the Town owns property, specifically known as the Grant McCormick Memorial RV Park, located at West Highway 50, which is primarily a municipal recreational area; and

WHEREAS, the Town owns property, specifically known as Gateway Park, located at 6th and Highway 50, which is primarily a municipal recreational area.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of Holly that:

Section 1: The primary use of these areas is community in nature and available at all times to the public.

Section 2. All park restroom facilities will remain locked except for a reserved event. Reservations may be made by calling the Town of Holly office. A deposit of \$50.00 per event must be made with the Town Clerk/Treasurer. A full refund will be made upon satisfactory inspection of the facility.

Section 3: The camper/RV daily fee of \$25.00 will be charged to all travelers and visitors to the Town of Holly who wish to avail themselves of this city service. This fee must be deposited with the Town Clerk/Treasurer or made through the drop box at the RV park.

Section 4: The camper/RV weekly fee of \$120.00 will be charged to all travelers and visitors to the Town of Holly who wish to avail themselves of this city service. This fee must be deposited with the Town Clerk/Treasurer at the Town of Holly office prior to occupying the site.

Section 5: The camper/RV monthly fee of \$300.00 will be charged to all travelers and visitors to the Town of Holly who wish to avail themselves of this city service. This fee must be deposited with the Town Clerk/Treasurer at the Town of Holly office prior to occupying the site.

Section 6: The tent daily fee of \$10.00 will be charged to all travelers and visitors to the Town of Holly who wish to avail themselves of this city service. This fee must be deposited with the Town Clerk/Treasurer or made through the drop box at the RV park.

Section 7: All fees collected will aid in the preservation, maintenance and upgrading of these areas.
