

# RESOLUTION NO. 2014-10

## A RESOLUTION BY THE BOARD OF TRUSTEES OF THE TOWN OF HOLLY, COLORADO AUTHORIZING RATE ADJUSTMENTS TO CERTAIN CLASSIFICATIONS RELATING TO THE WATER AND SEWERAGE FACILITIES OF THE TOWN OF HOLLY

WHEREAS, the Board of Trustees of the Town of Holly approved Ordinance No 470; Section 2: which set annual increases to be applied to monthly minimum usage of each meter served by the Town's municipal water system; and

WHEREAS, the Board of Trustees of the Town of Holly approved Ordinance No. 470; Section 7; establishing the rate charged for the coin-op water dock bulk purchases; and

WHEREAS, the Board of Trustees of the Town of Holly approved Ordinance No. 470; Sections 8, 9, 10 and 11 which pertain to the Town's sewerage utility classifications and annual rate tariff increases for all customers served within and without the corporate limits of the Town; and

WHEREAS, the Board of Trustees of the Town of Holly has reviewed the water and sewer utility reserves during the 2015 budget process and determined the current monies will sustain a stay on the 2015 approved annual increase to the rates detailed in Sections 2, 9, 10 and 11, and upon review of Section 7 realized the necessity to increase the rate associated with the coin-op water dock to assist with maintenance and/or upgrade costs;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of the Town of Holly hereby adjusts the following water and sewer rates of Ordinance No. 470:

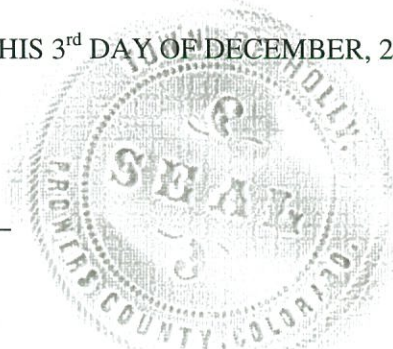
