

## RESOLUTION 2021-8

### A RESOLUTION SUPERSEDING 2007-9 AND 2011-1 BY THE BOARD OF TRUSTEES OF THE TOWN OF HOLLY ESTABLISHING RENTAL RATES FOR THE GRANT MCCORMICK MEMORIAL BALL PARK RECREATIONAL VEHICLE (RV) SPACES

**WHEREAS**, the Town owns property, specifically known as the Grant McCormick Memorial Ballpark, located at West Highway 50, which is primarily a municipal recreational area and RV park; and

**NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of Holly that:**

**Section 1.** The primary use of this area is community in nature and available at all times to the public.

**Section 2.** All travelers and visitors to the Town of Holly Camper/RV Park will be charged a fee according to the Fee Schedule. This fee must be deposited with the Town Clerk/Treasurer or made through the drop box at the RV park before occupying the space.

**Section 3.** In the event of a natural disaster, the Town of Holly, at the discretion of the Board of Trustees, may allow volunteers who come to the aid of the townspeople to stay in an RV space at no charge. Likewise, a building contractor aiding in natural disaster relief will only be charged \$15.00 per day.

**Section 4.** The south RV spaces will be designated for daily or weekly rental, whereas, the north spaces will be designated for long term rental. Long term parking will be for a period of no longer than 60 days.

**Section 5.** The full month payment is due the first Monday of each month. Mid-month stay will be prorated to make first Monday rent due applicable.

**Section 6.** The Board of Trustees has the right to approve long-term parking extensions. Written request must be submitted by camper prior to maximum parking period. All matters will be considered including camper's adherence to rules, alternative options available and community economy.

**Section 7.** The following Rates will apply to all travelers and visitors at the RV park.

**Section 8.** AS TO WIT, let it be known to all travelers and visitors at the RV Park that the following rules will be adhered to by all who rent or occupy space.

- You will maintain your space in a neat and clean environment. Straw bales used for insulation are prohibited.
- Your hook ups will be according to the Town of Holly specifications.
- You will not disturb the peace or have altercations at the RV Park.
- You will observe "Quiet Hours" from 10:00 p.m. to 6:00 a.m.

**Section 9.** All fees collected will aid in the preservation, maintenance and upgrading of this area.
