<u>Public Appearances.</u> Resident Barbara Dreiling was present to discuss the proposed modification to the Electric Rate Tariff schedules for the Town of Holly. Her concerns for any adjustment were expressed to the board. Mayor Simon encouraged her to attend the Public Hearing to be scheduled for April 2, 2014 at 7:00 p.m. in Board Chambers, 100 Tony Garcia Drive; Holly, CO. Objectives of the proposed modification will be detailed fully at that time.

Reports. Police Commissioner Report. Report was not available as of meeting time but will be emailed to Board. Crew Report. Electric line extension was installed between North Main Street and Highland Drive. Wind damaged utility pole and street light were replaced at the swimming pool park. Order placed for poles, wire and necessary materials for electric line extension south of town to service new irrigation customer. Several line fuses were replaced after the wind. Set meter loop and installed underground wire to electric service at new landfill building. Grett Electric required crew assistance when repairing services at Holly Housing Authority. Crew assisted contractor with building construction at landfill. Replaced hose on trash truck and repaired big dump truck bed and cylinder. Removed snow at Town facilities, emergency facilities and sanded streets. Placed order for a plate compactor to utilize when repairing streets. Potholes repaired at 8th and Park. Sewer problems inspected at three services and found to be customer's responsibility. Water leak repaired at meter pit at Stalford residence. Administrator's Report. ARPA filed suit in US District Court of Colorado today against Babcock and Wilcox (B & W)-Boiler Supplier for Lamar Repowering Project. The Town of Holly has entered into agreement with GP Irrigated Farms for electric service requiring primary line extension. Administrator mailed Advice Letter Number Eight (8) which details the

proposed modification to Electric Rate Tariff Schedules. Clerk/Treasurer Report. January Financials were presented in Board packet. 2011-2012 financials were compared with 2012-2013 financials. All financials summarized and reviewed with board. Trustee Anthony Moldenhauer motioned to approve the reports as given, seconded by Trustee Frank Vazquez excluding the Police Commissioner Report.
